The Revenue Neutral Rate Hearing for the 2022 budget of the Northeast Kansas Library System began at 2:00 p.m. Robert Miller, President, called the hearing to order.

Mr. Michael McDonald presented the 2022 budget in relation to the Revenue Neutral Rate.

Mr. Robert Miller called for any guests wishing to provide public comment on NEKLS' intention to exceed the Revenue Neutral Rate by 0.003 mills.

No public comments were made.

Robert Miller called on the System Board to consider Resolution 2021-5 to Exceed the Revenue Neutral Rate. <u>MOTION</u>: Kiersten Allen, Executive Board, moved to pass Resolution 2021-5, a resolution stating the Governing Body's intent to levy a property tax rate exceeding the Revenue Neutral Rate. Jack Granath, Executive Board, seconded and the MOTION WAS APPROVED by a vote of 53 yes and 1 no.

Robert Miller called for a motion and second to close the Revenue Neutral Rate Hearing. MOTION: Kiersten Allen, Executive Board, moved to close the Revenue Neutral Rate Hearing. Nancy Keith, Executive Board, seconded and the MOTION WAS APPROVED UNANIMOUSLY.

The Revenue Neutral Rate Hearing adjourned at 2:13 p.m.

Mr. Robert Miller, President, called the Budget Hearing to order.

The public hearing for the 2022 budget of the Northeast Kansas Library System began at 2:13 p.m. Mr. Michael McDonald began the hearing by presenting the 2022 Budget.

He then presented the 2022 System Plan.

Robert Miller called on guests to provide public comment on the proposed NEKLS budget.

Summer Taylor, Overbrook Public Library, asked to return to the General Fund page of the presentation. She wanted to know how we are able to save money on Motor Vehicle Tax and Recreational Vehicle Tax. Michael McDonald explained that those totals are provided to us by Douglas County.

Matt Nojonen, Leavenworth Public Library, (in reference to the KLE Courier Budget slide) asked about the increase in expenditures in the Contractual Courier line. Whether it was due to volume or cost of operations. Michael McDonald explained that according to the contract with the courier vendor, the rates per stop is stepped up each year and it is a 4-year contract. Carolyn Little, Executive Board, also offered that in 2020 the courier did not operate for a portion of the year and that reduced the contractual cost for that year.

No further public comments were made.

After the discussion, Robert Miller called for a motion and second to close the Budget Hearing. MOTION: Jack Granath, Executive Board, moved to close the Budget Hearing. Nancy Keith, Executive Board, seconded and the MOTION WAS APPROVED UNANIMOUSLY.

The public hearing on the budget closed at 2:34 p.m. and the System Board meeting began.

The annual System Board meeting was held via Zoom and in person at the Northeast Kansas Library System office at 4317 W 6th Street, Lawrence, Kansas on September 14, 2021. President Robert Miller called the System Board meeting to order at 2:34 p.m.

The President called for additions or deletions to the agenda. There were none.

President Robert Miller asked members of the Executive Board to introduce themselves.

The next three agenda items were Action Items. All Governor Appointees, Executive Board members and designated Library System Representatives, or their proxies, were polled electronically for approval of the August 13, 2020 Assembly minutes and 2022 Budget.

MOTION: Julie Clark, Olathe Public Library, moved that the August 13, 2020 Budget Hearing and System Board Meeting minutes be approved as presented. Kiersten Allen, Executive Board, seconded and the MOTION WAS APPROVED by a vote of 53 yes and 0 no votes.

<u>MOTION</u>: Nancy Keith, Executive Board, moved that the 2022 Budget be approved as presented. Kiersten Allen, Executive Board, seconded and the MOTION WAS APPROVED by a vote of 52 yes and 0 no votes.
