The Revenue Neutral Rate Hearing for the 2025 budget of the Northeast Kansas Library System began at 10:02 a.m. Robert Miller, President, called the hearing to order. He reminded attendees the process for making a public comment.

Mr. Robert Miller called for any guests wishing to provide public comment on NEKLS's intention to exceed the Revenue Neutral Rate.

Robert Miller called on the System Board to consider Resolution 2024-4 to Exceed the Revenue Neutral Rate. <u>MOTION</u>: Kiersten Allen, Executive Board, moved to pass Resolution 2024-4, a resolution stating the Governing Body's intent to levy a property tax rate exceeding the Revenue Neutral Rate. Virginia (Ginnie) Schirmer, Executive Board, seconded and the MOTION WAS APPROVED by a vote of 51 yes and 0 no.

Robert Miller called for a motion and second to close the Revenue Neutral Rate Hearing. MOTION: Ginnie Schirmer, Executive Board, moved to closed the Revenue Neutral Rate Hearing. Dennis Shelton, Linwood Community Library seconded and the MOTION WAS APPROVED UNANIMOUSLY.
